<p>Sponsorship</p> <p>(Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred in carrying out duties as a member, or towards the election expenses.</p> <p>This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992(a).</p>		
<p>Contracts</p> <p>(Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority -</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharge.)</p>		
<p>Land</p> <p>(Any beneficial interest land which is within the area of the relevant authority)</p>		

Interests	Yourself	Spouse / Civil Partner
<p>Licences</p> <p>(Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.</p>		
<p>Corporate tenancies</p> <p>(Any tenancy where to your knowledge) -</p> <p>(a) the landlord is the relevant authority; and</p> <p>(b) the tenant is a body in which the relevant person has a beneficial interest.</p>		

Interests	Yourself	Spouse / Civil Partner
<p>Securities</p> <p>(Any beneficial interest in securities of a body where -</p> <p>(a) that body where to your knowledge has a place of business or land in the area of the relevant authority; and</p> <p>(b) either -</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>
