Application for a Premises Licence: Tigerbite, 7-8 Mill Street, Stafford, ST16 2AJ

Purpose of Report

To consider an Application for a Premises Licence for Tigerbite, 7-8 Mill Street, Stafford, ST16 2AJ.

1 Detail

- 1.1 On 12 September 2025 the Council received an application for a Premises Licence for Tigerbite, 7-8 Mill Street, Stafford, ST16 2AJ.
- 1.2 The application is for a Late-Night Refreshment Licence to operate from 23:00hrs – 03:00hrs seven days a week.
- 1.3 The application was made by Sobeya Akhtar on behalf of the proposed Premises Licence Holder, Stafford Fastfood Ltd.
- 1.4 There have been no objections from any of the Responsible Authorities.
- 1.5 There have been two relevant representations from local residents and businesses who are concerned about potential nuisance from cars and delivery vehicles.
- 1.6 The objections relate to one of the four of the Licensing Objectives: the Prevention of Public Nuisance.

1.7 As part of the process, it is noted that Stafford Borough Council issued planning permission (with conditions) for development of the site dated 13 December 2023. With regards to the operating hours stated on that authorisation, the following conditions may be deemed relevant at this time:

- The opening hours of the restaurant and takeaway shall be between the hours of 11:00am and 03:00am as stated on application forms.
- All deliveries to the premises shall only take place between the hours of 8:00am and 18:00pm on any day
- A delivery only service shall operate from 23:00hours on any day

2 Previous Consideration

2.1 The same site previously held a premises licence under the premises licence holder Tiger Bite ST16 Ltd, with the following licensable activities and hours:

Provision of Late Night Refreshment (indoors)

Monday to Sunday - from 23:00hrs to 03:00hrs

Opening Hours

Monday to Sunday - from 12:00hrs to 03:00hrs

2.2 The previous Premises Licence was also subject to licence conditions as follows:

1. A noise management plan shall be submitted in writing to the Licensing Authority for the written approval of the Licensing Authority. The noise management plan shall cover all activities at the premises, including the use of the smoking area and ingress and egress from the premises. The controls and requirements of the noise management plan including any conditions attached to the written approval issued by the Licensing Authority shall be complied with at all times. This plan shall be subject to regular review and any changes necessary shall be submitted in writing to the Licensing Authority.
2. All staff are to be made aware of the license conditions, particularly the noise management plan.
3. A complaints procedure is to be put in place to deal with any complaints relating to the licensable activities.
4. All doors and windows to the premises are to be kept closed at all times, save for access and egress.
5. Clear and legible notices must be prominently displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and area quietly.
6. No customer shall be permitted to enter the premises after 22:45.
7. Customers and staff shall not enter or leave the premises after 23:00 by the front door on Mill Street, except in the event of an emergency.
8. The premises licence holder must instruct delivery riders and drivers not to cause a noise nuisance when making deliveries or whilst waiting outside the premises for collections.
9. Delivery vehicles shall switch off their engines whilst stationary and collecting orders for delivery. Delivery vehicle horns shall not be used at any time, except in accordance with the Highway Code.
10. Customers must be instructed when placing the order that they will not be able to collect the order from the vehicle. All deliveries will only be made directly to the property address and customers will not be permitted to take orders from the vehicle.
11. Noise from any ventilation, refrigeration or air conditioning plant or equipment shall not cause nuisance to the occupants of any properties in the vicinity.

Recommendation:

- (a) The Rating Level of any noise from any fixed plant shall not exceed the background noise level by more than 5dB at the nearest noise sensitive property as determined by BS 4142: 2014+A1:2019 Methods for Rating and Assessing Industrial and Commercial Sound’.
 - (b) Anti vibration mounts should be used to isolate plant from fixed structures and a flexible connector used to connect the flue to the fan if there is a potential to transmit vibration to any noise sensitive property. Any systems will also need regular maintenance to reduce mechanical noise. Guidance on the above can be gained from the ‘Control of Odour and Noise from Commercial Kitchen Exhaust Systems’ document published by EMAQ+.
- 12. The premises licence holder shall ensure that measures are put in place to remove litter or waste arising from customers and to prevent such litter from accumulating in the immediate vicinity of the premises or neighbouring premises.
- 13. The lighting at the front of the premises must be turned off at 23:00 hours each day
- 14. Waste from the premises must only be emptied to external waste receptacles between 08:00 and 23:00 hours.
- 2.3 This premises licence lapsed on 1 April 2025 due to the dissolution of the premises licence-holding company, Tiger Bite ST16 Ltd.

3 Human Rights Act 1998 Implications

- 3.1 Article 6 of the Act provides that where a person’s civil rights and obligations are being determined, the person is entitled to a “fair trial”. The Council complies with Article 6 in that it gives the person the opportunity to state their case, will make a decision within a reasonable period of time and will give reasons for its decision.
- 3.2 The Article also provides for the issue to be determined by an independent tribunal. The right of appeal to the Magistrates’ Court against the Council’s decision fulfils this.
- 3.3 The Council observes the rules of natural justice, and its procedures are consistent with Article 6 of the Human Rights Act 1998.

4 Recommendation

- 4.1 That the Licensing Sub-committee considers the application for the grant of a Premises Licence and considers whether to grant as applied for, or whether to add or amend conditions as deemed appropriate, taking into consideration the representations made before you.

Installation of internal and external CCTV system to monitor activity. This will be recorded 24 hours a day and be kept for 28 days.

Safe area for customers to place and collect orders separate from cooking areas

Promote our online ordering business model to deliver to customers directly without the need to attend the premises (this will lower the possible footfall inside the takeaway)

Seating area inside to be closed to the public from midnight each night.

The Store, albeit with a new Director, is still predominantly managed by the same Team, therefore adhering to our previously agreed conditions won't be an issue. Any new members of the Team will be suitably trained on the adopted conditions imposed

The Store intends to carry on with the previous agreements and conditions in place- last dine in orders via front access at 22.45. Lights shall be dimmed and the front door locked at 23:00 to reduce the appearance of being open, and therefore reducing the amount of foot traffic. Any in store music will be turned off at 23:00

All of Tigerbites delivery drivers are directly linked to us, and not those of third party aggregators such as Just Eat, Uber Eats etc. They need to abide by our internal policies, and can be managed on a daily basis by our Management Team. Any failures to adhere to our Policies can result in disciplinary action or dismissal where appropriate

b) The prevention of crime and disorder

Internal and external CCTV to be installed to monitor activities of all stakeholders. This will be recorded 24 hours a day and be kept for 28 days.

Competent person trained in the use of CCTV at premises while open to the public.

Current business model promotes the delivery of takeaway items therefore we would expect low levels of walk in customers and more online orders for delivery.

This is an extension of a current business with no previous history of public nuisance.

Incident register of all ejections from the premises can be maintained and provided.

Clear CCTV signage displayed to notify customers. Signage also to advise customers to be respectful of noise levels when leaving the property.

Seating area inside to be closed to the public from midnight each night.

No further operational changes have been made, so these findings remain valid.

Noise Assessment Report from October 2023 is attached. Despite it being historic, there will have been very few or no changes to the environmental surroundings, so I believe it should still remain valid.

Drivers shall turn their radio/music off upon entering the rear car park to reduce any detrimental noise impact. Drivers shall not leave their engines idle. Drivers cannot congregate and have conversation which may have a negative impact

All deliveries shall take place from the rear of the property where the noise threshold is higher. This has been the case under previous Directorship for over a year, where the Store has received no complaints with regards to increased noise/anti social occurrences

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or

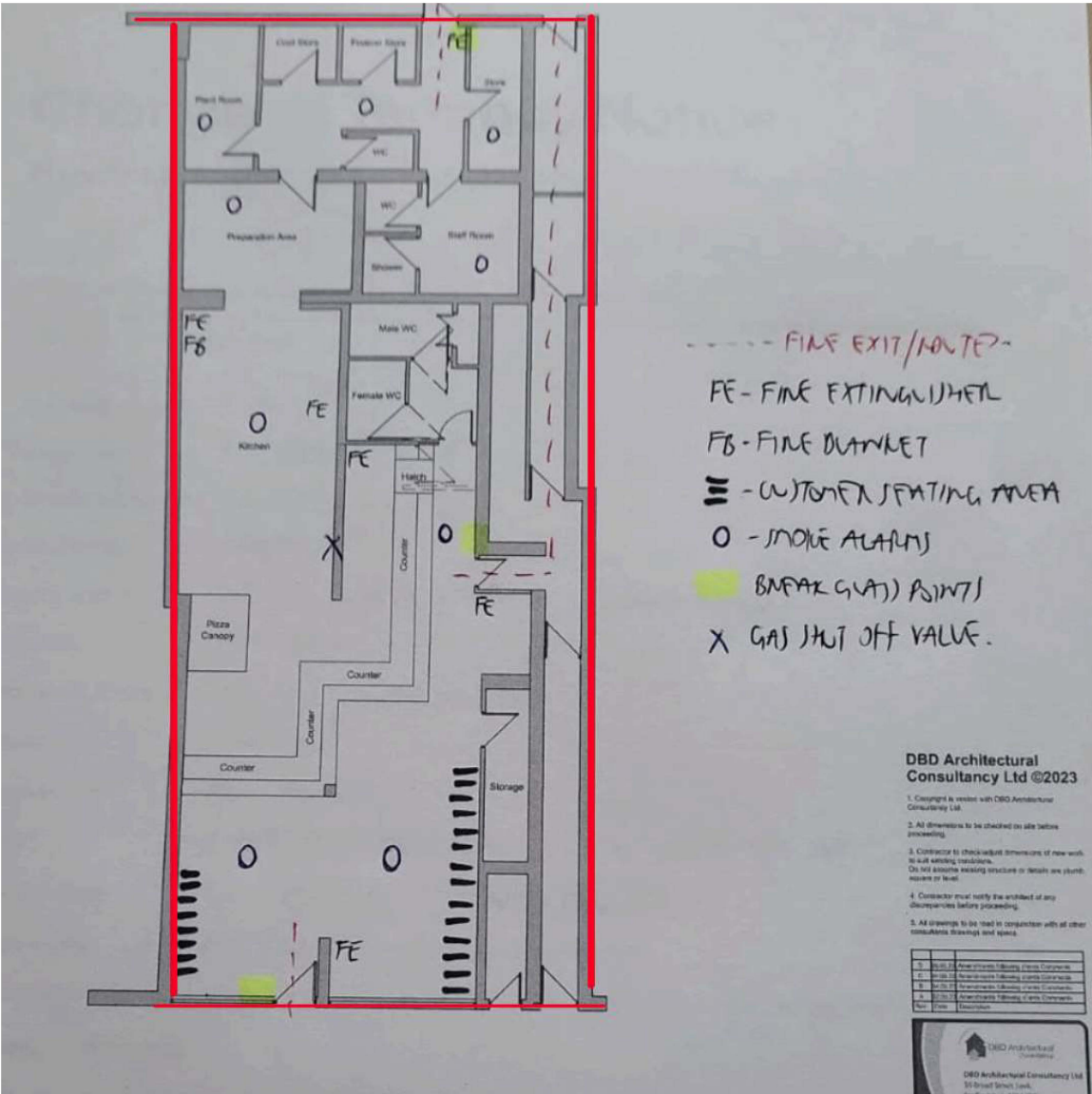

<u>SITE SUMMARY</u>				Ground floor, double fronted takeaway property, opening currently from 12:00 until 23:00, Monday to Saturday. Store currently operates 90% of its business as home delivery. With extended opening hours, this will rise to 95% +. Daily LNR licence granted until 03:00 based on a series of approved conditons. Offices above operating predominantly daytime. Music school operates until early evening.							
<u>KEY OBJECTIVES</u>				Minimise impact on local residents, particularly from a noise and public nuisance perspective. Need to satisfy local authority following a LNR licence hearing, which was granted based on a series of conditions. Suitably identify noise sources, levels and manage control thereof. Define a system to monitor noise, and communication with the public and relevant local authority.							
<u>LOCATION PLAN</u>				Ground floor within Mill Street, in close proximity to neighbouring shops and offices above. There are also four neighbouring residential properties nearby where any excess noise could have a detrimental effect. Front entrance of property borders onto a narrow street with low noise threshold. Rear of proprty abcks onto two car aprks which sits on a busy road inbetween the canal and bars, and is a high traffic exit route. As we don't intend to run any events other than our daily operation, there should be no sharp or prolonged activity of excess noise.							
<u>NOISE SOURCE INVENTORY</u>				Noise or distraction to local residents outside of the permitted 08:00-23:00 window will likely occur from the front door area bordering onto Mill Street, the rear area car park bordering onto Mill Bank bus and taxi route, and from our extraction system which runs externally at the rear of our property. Drivers would collect and leave via our rear entrance, so potential for elevated noise.							
<u>NOISE CONTROLS</u>				<p>To reduce noise outside of permitted times, external contractors, eg- waste collection and food deliveries- cannot access site until 08:00, and not after 18:00. Lights at front of shop which could attract customers outside of standard hours, to be switched off at 22:45 which would be last collection time for in store. Lights within front area of takeaway have been isolated, so these can also be switched off at 22:45 to reduce visibility to passers by, and therefore lower risk of public nuisance. No music presently in store. However, if introduced, this would be kept at a reasonable level throughout, and switched off at 22:45 in conjunction with walk in closure. 100% delivery service after 23:00, and only to fixed abodes. Drivers in the evening are from our internal driver team, so no reliance on Uber Eats/Just Eat drivers, meaning we can implement a code of conduct that forms part of their contract. This would include commitments regarding noise- any in car music must be turned off before entering car park on Mill Bank. Driver must approach quietly and cannot congregate, and remain in car until their pick up is ready, limiting the potential noise and disturbance. Any driver not following this is subject to review and potential consequence if deemed necessary. Extraction fans- currently waiting noise readings, but from professional opinion, these are lower than usual. Fans are fitted with a silencer to reduce noise output. Readings will be confirmed once given, and we can compare this to local authority for acceptable noise levels. Currently no walk in refrigeration which would require extrenal compressors. From speaking to local community, the noise generated by thre previous tenants was minimal at best, and generated no issues. We are currently running with less noise generating. All team must leave quietly via the rear door. Internal poster dplayed to all team and drivers asking for quiet upon exit in order to respect local neighbours.</p>

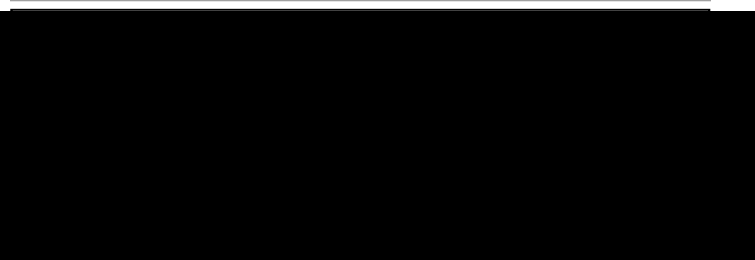
