## **Introduction**

The Gnosall Neighbourhood Plan covers the whole area of Gnosall Parish and contains a stated Vision, 5 Key Objectives and 14 planning policies. It covers the period 2011 to 2031, the same as the Local Plan (the Plan for Stafford Borough). Once the Neighbourhood Plan is adopted ("made") its policies will form part of the "Development Plan" for the area and will be used by the Local Planning Authority (Stafford Borough Council), alongside the planning policies in the Plan for Stafford Borough, to determine planning applications in the Parish. The Neighbourhood Plan policies will also be used to inform and underpin Gnosall Parish Council's consultation responses to planning applications within the Parish

The Neighbourhood Plan has been produced based on a range of evidence, including national planning policy and guidance, Local Plan policy and data and evidence and information collected from within the Parish during preparation of the Neighbourhood Plan, in particular the comprehensive community questionnaire survey.
