## **PC11 Application 23/37193/FUL - Land North of Marston Grange, Marston**

(Recommend: Approve, subject to conditions)

A site visit took place at 11:10am on Tuesday 23 June 2026. The site was viewed from a currently unnamed road off Bellardia Road.

Considered the report of the Head of Economic Development and Planning regarding the matter.

**PC12 Application 24/38719/FUL - Stallington Sprink, Stallington Road, Blythe Bridge**

(Recommend: Approve, subject to conditions and no intervention by the Secretary of State)

A site visit took place at 10:05am on Tuesday 23 June 2026. The site was viewed from Blythe Cricket Club, private drive off Stallington Road, Fulford Church, Long Lane and the site entrance.

Considered the report of the Head of Economic Development and Planning regarding the matter.

Public speaking on the proposal was as follows:

Parish Councillor J Crossley spoke in objection to the application.

Claire Chamberlain, Sarah Rocks and Beth Thomas spoke in support of the application.

At the invitation of the Chairman, Councillor M G Dodson, Fulford Ward Member, addressed the Committee. Before speaking on the application, he raised a point of order to seek clarification of the designation of the land, stating that previous applications nearby had been refused due to the land being greenbelt, but this application stated the land was greybelt.

The meeting was adjourned at 13:14pm to seek clarity on the designation of the land.

The meeting reconvened at 13:34pm, where the Principal Solicitor recommended that it was appropriate to defer the meeting pending clarification of the designation of the land.
